2024 AUGUSTA BOWLING SENATE TNBA TOURNAMENT RULES AND REGULATIONS

ENTRY DEADLINE: ENTRIES close midnight, October 5, 2025

1. This tournament is certified, operated under the tournament rules of, and open to all TNBA and USBC associates. Any member who does not hold or has not applied for TNBA membership prior to bowling will be disqualified. TNBA membership cards can be purchased on site at a cost of \$35. Unattached USBC associate cards may be purchased at the tournament.
2. The tournament will consist of MIXED TEAMS and MIXED DOUBLES. Optional handicap singles while bowling doubles. Separate singles division for women and men. Men cannot enter the women's singles and the women cannot enter the men's singles. If you are bowling on more than one team, please send all entries in together.
3. **Multiple entries will be permitted.** Only two (2) entries per event (Team, Doubles and Singles). Teams and Doubles can only cash once with the same partner. Singles can cash only once. Teams will consist of four (4) players (bowlers) with any mixture of men/ women combination. Doubles will consist of one (1) male and one (1) female. Team re-entry must have two (2) new players (bowlers) and Doubles must have one (1) new player (bowler).
4. Fees shall be remitted in the form of money orders, or certified checks and must accompany the application. Entry fee is \$45 per event. Please make checks payable to *AUGUSTA BOWLING SENATE TNBA*.
5. ENTRY FORMS MUST SHOW THE FULL NAMES, and TNBA and USBC CARD NUMBERS FOR EACH BOWLER. Omissions will delay processing. **(NO NICK NAMES)**.
6. SOCIAL SECURITY NUMBERS will be required for all bowlers, prior to prize winnings being mailed. **(NO NICK NAMES)**
7. Errors in scoring must be reported to the tournament director within 72 hours.
8. Entrants must use their highest (21 game minimum) USBC certified league average for the bowling season 2024-2025. All others will use their highest (21 game minimum) certified average as of September 30, 2025. Written verification must be submitted signed by the local association manager or league secretary. Average verification must be sent with entry or secretary signature with phone number. If entrants have none of the above information, the entrant must bowl with a 230 average. USBC rule 319d- reporting prize winning will apply. USBC 319c-average adjustment will apply (If you have been rerated, you must report your re-rated average).
9. It is the bowler's responsibility to verify the accuracy of his/her average. Failure to use the proper average or make a correction within 48 hours of the completion of the series shall disqualify scores if submitted average is lower than actual average or base USBC rule 319a-3. Any bowler whose highest current average is 10 pins or more above his last season's average must use his highest current average.
10. Replacements shall be permitted, and the bowler must bowl in the position of the original entrant. All rules and regulations herein likewise apply to replacements. All changes must be made one hour prior to bowling
11. Tardy player will be given ZERO for (0) pins for each frame missed. If a team refuses to start because a full line-up is not present, all games which they decline to bowl will be forfeited. No blind scores will be permitted, and a bowler must bowl with and on the same lane and at the same time his/her team bowls.
12. **Walk – Ins and re-entries are welcome based upon lane availability. All entries must sign-in 1 hour prior to scheduled squad time.**
13. Check-in will be done at the assigned lanes. (TNBA & USBC cards required)
14. Prize funds will be returned 100% in each event Team, Doubles. Optional Handicap Singles prize fund will returned 90%. The payout ratio will be at least 1:8 in each event including the optional Singles for Men and Women.
15. After an entry has been received, no fees shall be refunded, except in dire emergencies such as strikes, lockouts, scheduling conflict, fires, etc., over which management has no control.
16. The Tournament Committee reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA, and USBC.
17. Handicap is 100% of 230 for both men and women. Handicap will be figured individually per bowler
